## **Prenatal Laboratory Testing**

This guide is intended to help patients navigate the billing and insurance issues associated with commonly ordered laboratory testing in pregnancy.

For our patients' convenience, a Patient Service Center is located on the first floor of our 90th Street location where most routine blood work can be performed. The Patient Service Center is independently owned and operated – the Practice has no role in the provision of services or billing processes that result from the work done there.

If your insurance plan has restrictions or limitations on lab work, please make that known to our clinical staff. Provided you let us know in advance of a test being performed, we can frequently route routine samples to labs that will accept your insurance. For some of the specialty tests required where there are only a limited number of reference labs capable of performing them, that cannot be accomplished and patients will be responsible for the potential fees incurred.

We encourage patients to thoroughly research their coverage before consenting to testing to learn if copayment, coinsurance or deductible charges might apply, or whether precertification is required. While we will assist patients wherever possible, the Practice has no role in or control over billing issues and insurance requirements related to clinical laboratory fees.

Be advised that a physician's prescription or clinical recommendation for a lab test(s) is not a guaranty of coverage. It is a patient responsibility to determine whether their insurance plan provides coverage for the lab tests they consent to have performed.

To facilitate discussions between patients and their insurance companies, on the reverse side of this page is a list of commonly ordered specialty genetics tests, associated CPT codes, and contact information for the laboratories that provide them.

In our experience, these are the tests that can most frequently present billing issues for patients to be aware of. Patients are advised to contact their insurance company and/or the laboratory to learn more about their potential financial responsibility before consenting to testing.
